4. First-aid measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures: Keep unauthorized personnel away. Ventilate closed spaces before entering them. Use personal protective equipment. See Section 8 of the MSDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

Methods and material for containment and cleaning up: Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Clean surface thoroughly to remove residual contamination. Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures: Inform authorities if large amounts are involved.

Environmental precautions: Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

7. Handling and storage

Precautions for safe handling: Use personal protective equipment as required. Avoid contact with eyes, skin, and clothing. Do not eat, drink or smoke when using the product. Wash hands thoroughly after handling. Do not handle until all safety precautions have been read and understood.

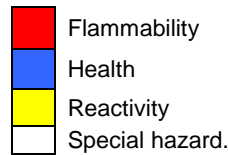
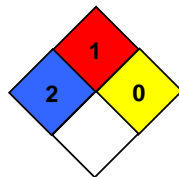
